**THE SACKETT GROUP ANNOUNCES RELEASE OF LEGAL MACPAC NUMBERING 9.9.1
WITH NEW PRICING OPTIONS FOR SMALL AND MID-SIZED LAW FIRMS**

**#1 Macro/Template Provider Extends Numbering Tool Functionality
to Include Support for Microsoft Office 2007 and Vista**

December 20, 2007 – San Francisco, CA The Sackett Group, Inc. (www.legalmacpac.com) introduces version 9.9.1 of the Legal MacPac Numbering Tool, an add-on to the widely-used Legal MacPac macro/template product. MacPac Numbering provides customizable, flexible paragraph numbering schemes for litigation and business transactional documents. The product is available either as part of Legal MacPac or as a standalone, independent application which can be bought separately from the macro/template system. With the release of 9.9.1, The Sackett Group also debuts new pricing options, which make the product more affordable for small and mid-sized law firms.

This new version of MacPac Numbering includes many major enhancements and new capabilities. Highlights of the new functionality include support for Microsoft Word 2007 and Vista (as well as earlier versions of Word and Windows operating system), scheme enhancements at the user and administrator levels, foreign-language numbering support, and additions to the toolbar/ribbon and table of contents features.

What's New in MacPac Numbering 9.9.1

- **Compatibility with Microsoft Word 2007**

MacPac Numbering now fully supports Word 2007. In Word 2007, the traditional MacPac Numbering toolbar has been replaced with a tab and ribbon, which includes the same functionality as before despite a different appearance. Shortcuts and hotkeys have been changed to better integrate with Word 2007. MacPac Numbering is compatible with Microsoft Word version 2007 back to Word 97.

- **Support for Microsoft Vista**

MacPac Numbering is now fully compatible with Microsoft Vista and can be configured to use Microsoft's recommended best practices for installation locations.

- **Scheme Management Enhancements**

Several scheme-related additions and enhancements have been incorporated into MacPac Numbering. These improvements make the product easier for the end-user and administrator alike to manage and customize effectively for their unique needs.

Additions include the "Edit" button as well as one-click access to other frequently used features, an option to "Insert Level 1 Automatically," and expansion of the "Make Scheme Active" functionality to manage multiple schemes more easily in documents.

- **Table of Contents (TOC) Field Code and Hyperlinks**

MacPac Numbering administrators can now easily configure the TOC dialog to include an option to generate a table of contents as a field code. An "Insert entries as hyperlinks" checkbox option also has been added.

- **Foreign Language Numbering Support**

MacPac Numbering supports all number styles available in native Word, and all dialog controls that can potentially receive input from users or administrators (e.g. textboxes) now support Unicode characters.

In addition to the abovementioned new features and enhancements, MacPac Numbering includes many other improvements to its toolbar/ribbon and table of contents features.

New Pricing Options for MacPac Numbering Tool

Small and mid-sized law firms can take advantage of new pricing brackets for the MacPac Numbering Tool. User-based license pricing ranges have been divided into more brackets to benefit smaller firms or corporate legal departments.

The Sackett Group president and founder Linda Sackett comments, "The MacPac Numbering Tool is currently being used by approximately 500 law firms and legal departments and that number continues to expand. Due to its popularity among MacPac users, Numbering is now

available either as part of the macro/template product or as a standalone product. Also, we have added new pricing options which will allow more small and mid-sized law firms and corporate legal departments to purchase the Numbering Tool.”
